- Woodworm issue raised last year has was resolved successfully
- New heating system has given hirers of the hall opportunity for greater usage throughout the year
- Regular hirers use the hall weekly / monthly which provides a steady income
- Advertising continues with a strong social media presence on Facebook plus our website
- Thanks to all the community for supporting the Hall and to the committee for all their hard work throughout the year
- Lastly to our Treasurer 'Jenny Patterson' who is stepping down this year we thank her for her tireless efforts to maintain a healthy financial position especially during such uncertain economic times

## Secretarys Report:

- Introduction Thanked everyone for attending
- Since last AGM the committee has held 11 meetings which are usually monthly plus one 'Extraordinary' meeting to discuss the plans for the 100<sup>th</sup> anniversary celebrations. Minutes are taken at all meetings – copies of these can be found on our website
- We have six Trustees for the hall. I would like to take this opportunity to thank Joel
  Dowling who has been involved with the hall for many years for his commitment and
  support. Joel has decided to resign as Trustee. Also our thanks to Simon Lackford for his
  support and involvement with the committee, Simon decided to also resign last year
- Welcome to our newest committee member Grahm Betteridge. Graham kindly joined us in the last month or so
- Going on from what Pete has already said our Facebook page and website continues to be a great way to reach a wider audience for advertising our fundraising events which we hold throughout the year
- As Secretary I have also been responsible for all 'Bookings' for the Hall. From this month bookings will be handled by Judith Bower. I will hand over to her later in April and inform all our regular users
- PB Thank you to our Secretary for all her input and secretarial duties

#### Treasurers Report:

- Balance sheet
  - o Compared to 2023, donations slightly reduced, however S/O increased
  - No need to use deposit account
  - o Income increase due to start of 100 club
  - Electricity reduced at present, this may increase
  - Electrical checks Electrician suggests this can be increased from 2 to 3 yearly
  - Water Rates increased

- Insurance increased slightly
- Service of heating still to take place Costing approx. £500
- Further refurb costs Purchase of more chairs, new boiler, new doors
- o No report to the 'Charity Commission' as income below £10,000
- Approx running costs for Hall £3,600 (Electricity/Water/Insurance/Fire Checks)
- Account in healthy position going forward
- PB At this point the present committee now resign and a new committee elected.
- PB Standing down as Chair. Present committee members agree to continue. Voting now to take place for principle members as follows:
